6. Unity and Solidarity

According to Tuan Guru Bajang (TGB) Muhammad Zainul Majdi, wasathiyah is a middle path that balances belief and tolerance, thereby creating harmony and peace in a diverse society (A. Aziz, 2025). Thus, the importance of a middle path in religious moderation is a solution to the challenges of intolerance and radicalism.

9. Tawazun (Balance)

Balance is a fundamental principle in religious moderation that guides each individual to treat everything proportionally and fairly (Syahri, 2021). This principle includes harmony between worldly needs and spiritual orientation, so that a person does not become immersed in material matters while neglecting spiritual aspects, or vice versa. In addition, balance is also seen in the fulfillment of rights and obligations, where every action and decision is based on a sense of responsibility, fairness, and not harming others. Thus, balance becomes a guideline for creating a religious life that is harmonious, wise, and beneficial to oneself and others.

4. Acting as a filter against the influence of transnational ideologies

3. The impact of digital disruption

The digital era brings a rapid flow of information. Unfortunately, social media is often used to spread hate speech, intolerance, and radicalism. Without the filter of universal religious values, people are easily provoked by the massive spread of extreme narratives (Muttaqin, 2023).

4. Lack of inclusive religious education

Some educational institutions still teach religion using an exclusive approach. This results in universal religious values, such as tolerance and respect for human dignity, receiving less attention. As a result, the younger generation is not accustomed to moderation in their daily lives (Nurdin & Asrori, 2020).

5. Lack of role models among religious leaders

Religious leaders have a strategic role as role models. However, not all religious leaders are able to display moderate attitudes. When religious leaders are exclusive or intolerant, this has the potential to spread to their followers and weaken religious moderation.
